7. BUSINESS ARISING FROM MINUTES

George Kuhse – All nominations for the King Charles Coronation Medal announced by the Government of Canada are in. David Jackson and his committee members will be asked by the President to determine a topic for the next symposium within the next 60-calendar days so that preparations for guest speakers can begin. Military attaches were mentioned as a possible source of information and contact as well. The Edmonton Inn & Convention Centre is a possible venue for hosting the next Symposium.
