Project (CPSP) and has signed a technical cooperation agreement with Babcock Canada." And let's buy twelve submarines. Canada has three oceans, three fronts, one of them, the Arctic, fronting Russia.



War In Ukraine

Russia Investigates Disappearance of More Than 50 Missing Aircraft as Allegations of Move to "Unfriendly Countries" Such as Ukraine Emerge.

Mid escalating tensions in the ongoing conflict between Russia and Ukraine, investigations have been launched into the disappearance of multiple Russian aircraft. Suspicions abound that some of these aircraft may have ended up in the possession of Ukrainian forces, intensifying geopolitical concerns and prompting official inquiries into alleged unauthorized transfers. Numerous reports suggest that several Russian aircraft, including Mi-8 helicopters and an II-76 strategic airlifter, have disappeared under suspicious circumstances, coinciding with heightened military activities in Ukraine. Ministry of Transport audits conducted in July 2023 uncovered inconsistencies in Rosaviatsiya's records, leading to suspicions of improper removal of aircraft from the civil aviation register without adequate documentation. The Federal Security Service has initiated criminal investigations, citing negligence and abuse of power, targeting individuals associated with the suspected unauthorized transfer of aircraft. Allegations have surfaced regarding the unlawful removal of 59 planes and helicopters from Russian jurisdiction, raising questions about the circumstances surrounding their disappearance.

Officials from the Federal Air Transport Agency are under scrutiny for alleged deficiencies in documenting the removal of aircraft, contributing to uncertainties regarding their current whereabouts. Rosaviatsiya, responsible for overseeing Russia's civil aviation sector, faces scrutiny over its handling of aircraft ownership rights and transactions, amid allegations of irregularities. The Mi-8 helicopter, extensively utilized by Russian forces, has emerged as a key point of interest, with Ukrainian claims of downing these helicopters further exacerbating tensions. Reports of aircraft incidents, including crashes and disappearances, have heightened concerns about the safety and security of aerial operations amidst the ongoing conflict. Ukraine

has repeatedly claimed the shooting down of Russian aircraft and has reportedly seized at least one Russian helicopter, adding another dimension to the complex dynamics of the conflict. In a significant development, Ukraine reported the capture of a Russian Mi-8 pilot, underscoring the intensifying nature of the conflict and its broader implications for regional stability.
